WARNING: THIS AGREEMENT IS LEGALLY BINDING. BY SIGNING YOU GIVE UP YOUR RIGHT TO RECOVER ANY COMPENSATION FOR ANY PERSONAL INJURIES, DAMAGE TO YOUR PROPERTY, OR FOR YOUR DEATH, ARISING OUT OF YOUR USE OF RV/CAMPER SHARE LLC'S, A MINNESOTA LIMITED LIABILITY COMPANY ("RV/CAMPER SHARE"), WEBSITE, RVCAMPERSHARE.COM (THE "SITE"), AND THE SERVICES OFFERED THROUGH THE SITE, INCLUDING THE RENTAL OF VEHICLES SUCH AS RVs, CAMPERS, AND POWER SPORT VEHICLES, INCLUDING ATVs, UTVs, SNOWMOBILES, MOTORCYCLES AND ALL WATERCRAFT (COLLECTIVELY, "EQUIPMENT"), FROM THIRD-PARTIES UNRELATED TO RV/CAMPER SHARE, OR ARISING OUT OF YOUR USE OF ANY EQUIPMENT RENTED THROUGH THE SITE AND ACTIVITIES RELATED THERETO ("ACTIVITIES"). YOU ARE RELEASING RV/CAMPER SHARE, ITS EMPLOYEES, AGENTS, OFFICERS, OWNERS AND SUCCESSORS, AND ANY PERSONS USING RV/CAMPER SHARE'S SITE. THIS AGREEMENT IS BINDING ON YOU, YOUR HEIRS, NEXT OF KIN, ASSIGNS, AND PERSONAL REPRESENTATIVES. IF THE PARTICIPANT IS UNDER THE AGE OF 18, THE UNDERSIGNED REPRESENTS HE/SHE IS THE CHILD'S PARENT/LEGAL GUARDIAN, AND THIS AGREEMENT IS EXECUTED ON BEHALF OF THE PARENT/LEGAL GUARDIAN AND THE CHILD.

I, the undersigned, acknowledge and understand RV/Camper Share provides an online platform that connects owners who have Equipment available for rent with customers seeking to rent Equipment, which platform is accessible via the Site and any other websites through which RV/Camper Share makes the platform available. I understand and acknowledge RV/Camper Share does not own the Equipment and has no liability related thereto. I acknowledge and agree the use of the Equipment has INHERENT RISKS, including, but not limited to, the following: injuries or death resulting from the failure or negligent misuse or operation of the Equipment; injuries resulting from collisions, mechanical failure of the Equipment, the failure to properly operate the Equipment, and/or the physical demands associated with the use of Equipment; injuries resulting from other persons who may come into contact with me while operating Equipment; injuries occurring from the negligence or lack of adequate training on the use of the Equipment or other persons assisting with medical or other help either before or after injuries have occurred; injuries resulting from the failure of Equipment; injuries resulting from the negligence of RV/Camper Share's owners, operators, employees, or agents, the negligence of other renters, owners of the Equipment, or other persons utilizing the Site, the negligence of the designers, manufacturers or installers of the Equipment; and/or injuries resulting from other services offered by RV/Camper Share through the Site.

I am aware of these and other risks in using RV/Camper Share's Site and the Equipment and other services offered by RV/Camper Share. I VOLUNTARILY ASSUME COMPLETE RESPONSIBILITY for these risks and for the injuries that may occur as a result of these risks EVEN IF injuries occur in a manner not foreseeable at the time I sign this agreement. I realize that by voluntarily assuming the risks involved, I am SOLELY RESPONSIBLE for any loss or damage I sustain, including PERSONAL INJURIES to me, damage to my PROPERTY, damage to the Equipment (whether caused by me, other renters, or the owner of the Equipment) or damage arising out of my DEATH.

In consideration of my or my child's observing or using RV/Camper Share's Site and/or the Equipment, and/or in consideration of my or my child using the Site and Equipment I, on behalf of myself, my heirs, administrators and personal representatives, hereby RELEASE RV/CAMPER SHARE AND FOREVER DISCHARGE RV/CAMPER SHARE FROM ANY AND ALL LIABILITY, and PROMISE NOT TO SUE RV/CAMPER SHARE, or any of its owners, officers, directors, employees, or agents for any claims, losses, damages and/or demands arising out of any PERSONAL INJURIES sustained by me, my child, damage to my/my child's PROPERTY, damage to the Equipment (whether caused by me/my child, other renters or the owner of the Equipment), or my/my child's DEATH.

If any provision of this Agreement is held invalid, the invalidity shall not affect other provisions of the Agreement which can be given effect without the invalid provision, and to this end the provisions of the Agreement are severable. This Agreement shall be governed by the laws of the State of Minnesota.
